e-ASIA JRP 15th Call for Proposals Webinar: Comprehensive Guide to Research Priorities, Eligibility Criteria, and Common Application Challenges

The e-ASIA Joint Research Program (e-ASIA JRP)

1. Background

The e-ASIA Joint Research Program (e-ASIA JRP) has launched its 15th Call for Proposals (December 17, 2025), inviting researchers to submit international collaborative projects in Agriculture, Alternative Energy, and Health Research. This call offers a valuable opportunity to build cross-border research partnerships and contribute to solutions addressing shared regional challenges.

Experience from earlier calls has shown that navigating national eligibility requirements across participating countries is a critical step in both the application and eligibility screening process. To support prospective applicants in preparing eligible and competitive proposals, an informational webinar will be held.

2. Purpose

This webinar aims to provide prospective applicants with clear, practical guidance on the national eligibility requirements for the 15th Call for Proposals and the application process. The session will introduce the e-ASIA JRP framework, outline research priorities across the fields of cooperation, and highlight important points to consider before submission.

Based on experiences from previous calls, the webinar will address common eligibility issues and missteps, clarify key national requirements, and share practical tips to help

applicants strengthen their proposals and avoid avoidable disqualification. Participants will gain:

- A clear understanding of eligibility criteria and country-specific differences
- Insight into common issues that have resulted in ineligibility in past calls
- Practical advice to improve proposal compliance and overall quality

Unlike previous e-ASIA JRP workshops for the last Call for Proposals, this webinar is fully focused on guidance and clarification, ensuring participants leave with the understanding needed to prepare and submit a compliant, well-prepared proposal.

the program's overall goals, objectives, and how it supports multilateral joint research. Participants will gain a clearer understanding of how the program facilitates international collaboration under the e-ASIA JRP.

- **Session 2: Research Priorities Under the 15th Call for Proposals**

This session will present the research priorities for each field of cooperation under the 15th Call. Key research areas will be highlighted, along with updates or changes compared to previous calls. Participants will also learn about research areas that will not be supported under this call.

- **Session 3: Eligibility Criteria and Common Challenges in Applications**

This session will focus on eligibility considerations for the 15th Call for Proposals, with emphasis on national eligibility requirements. Participants will gain practical insights into how eligibility is assessed and how to align proposals with the rules.

- A) Overview of common requirements, including project consortium composition and funding arrangements under the e-ASIA JRP.
- B) Overview of national eligibility requirements, highlighting frequently encountered issues and sharing practical, experience-based guidance to support applicants in preparing compliant proposals.
